**What should you bring with you?**

- All W-2s and 1099s (if any) for the year involved
- Social Security cards or Individual Taxpayer Identification Numbers (ITINs) for all family members
- Valid photo ID for the person filing and spouse, if applicable
- Copy of previous year's tax return, if available
- Checking and savings account and routing numbers to direct deposit your refund
- Property tax bill
- Amount spent on college expenses
- Any letters from the IRS, if applicable
- Copy of tax return or tax transcript if filing an amended return
